Surcharge Policy

- 1. Surcharges are applicable at time of shipment unless otherwise stated at order entry.
- 2. Surcharge values are calculated utilizing the monthly average prices 90 days prior. Example: April surcharges are calculated from January reference values.
- 3. Surcharges are calculated for each alloy based upon a formula utilizing the chemical composition of the alloy, the effective yield from melt, and the delta between base values and the current market values.
- 4. In the event that raw material prices fluctuate more than +/- 10% from the previous month, Electralloy reserves the right to modify the current monthly surcharge.
- 5. Electralloy reserves the right to add additional components and/or producer premiums to the surcharge formula as required.
- 6. Electralloy is the exclusive producer of Nitronic®40, Nitronic®50 and Nitronic®60 in North America.
